7.2 Official Plan Update - Ongoing

Ms. Jabbour advised the Town is working on Phase 2 of the Official Plan to revise the policies, including cultural heritage and are looking for feedback from residents.

7.3 Heritage Grant Program

7.3.1 Update on the Heritage Property Tax Grant

Ms. Cheyenne Mailloux met with the Finance Department to determine the feasibility of a property tax grant. Ms. Jabbour would like to get input from Heritage property owners and will do so during Heritage Week activities.

7.4.1 Update on the Snider House Plaque - 179 County Road 50 West

Ms. Jabbour advised the plaque has been ordered. It will be ready in March and will be unveiled in the Spring.

7.5 Listing and Designating Properties and Heritage Districts - Ongoing

7.5.1 Update on Rio Theatre - 10 Talbot Street South

Vice-Chair Kokovai was unable to find any information on the Rio Theatre. We will keep this item on the agenda to allow more time to search the history.

7.5.2 Update on 136 County Road 50 West

Member Baldwin provided a lot of information. We will keep the item on the agenda to allow further time to review.

7.5.3 Essex Railway Station, 87 Station Street, Essex Centre (Ward 1)

Ms. Cheyenne Mailloux discovered that on December 31, 2003, as a result of amalgamation all Heritage Property Designation by-laws were rescinded. As a result, the Essex Train station is not in fact designated. Ms. Mailloux provided an overview of the history, emphasizing its survival of two explosions and its historical and contextual value. It is a historical landmark of Essex.
