### Recommendation(s)

**That** Parks and Facilities-2022-10 entitled "Request of Additional Funds for the Replacement of Rink Netting at the Harrow and Colchester South Community Centre", prepared by Jake Morassut, Director, Community Services dated June 20, 2022 be received, and

**That** Council **approve** an additional \$3,512.06 to be funded from the Asset Management Reserve for capital project CS-22-0040 "Harrow Arena Spectator Netting".

### Purpose

Council approval is required to approve funding allocations outside of the annual budget.

## Background and Discussion

During the 2022 budget deliberations, Council approved that Parks and Facilities replace the netting at the Harrow and Colchester South Community Centre. The Town of Essex approved \$18,000.00 in the capital budget.

The project was posted for public tender on the Town of Essex website and MERX with no submissions. The project was then sent out to several vendors as an Informal Request for Quotation, in accordance with By-Law 2129, with only two submissions. The price submitted from Sound Barriers was \$21,512.06 (includes the non-refundable tax).

Administration reviewed the submissions for specification compliance and found it to be complete. The results of the submitted tender prices are noted in Table below:

Name of Tenderer	Total Tender price including non-refundable Harmonized Sales Tax (1.76%)
Sound Barriers	\$21,512.06
Welmar Recreational Products Inc.	\$27,465.02

Based on the pricing provided in the submission above, with additional funding coming from the Asset Management Reserve, it is recommended that the purchase of the Replacement Rink Netting at the Harrow and Colchester South Community Centre proceed from Sound Barriers.

## Financial Impact

The approved capital budget (CS-22-0040) for this project is \$18,000.00 and the lowest tender price was \$21,512.06 (includes the non-refundable tax), leaving a funding deficit of \$3,512.06, to be funded from the Asset Management Reserve.
