Recommendation(s)

That Legal and Legislative Services-2022-25 entitled Sidewalk Patio By-Law prepared by Maja Bakalic, Assistant Manager Legal & Licensing dated June 20, 2022 be received, and

That By-Law Number 2160 Being a By-Law to regulate the use of sidewalk patios within geographical boundaries of the Town of Essex receive a first, a second and a third reading and be finally passed this 20th day of June 2022.

Purpose

This report's purpose is to propose a By-Law to provide Eligible Businesses seasonal access on Municipal property for Sidewalk Patios.

Background and Discussion

The Town currently does not have a sidewalk patio bylaw. In the past when there have been requests to develop or extend a patio onto public lands the matter has been dealt with as a customized request for an Encroachment Agreement with the Town.

During the Covid-19 pandemic the LCBO introduced automatic temporary extensions of a liquor license which extensions did not require formal LCBO application but was only conditional upon the towns approval thereof including approval of the physical extension of the patio itself onto the public sidewalk. In response to this pandemic measure and in order to try to assist local businesses the Town developed a temporary and expedited application process in order to provide for expedited approvals for businesses to develop or extend their outside patios as a pandemic relief measure in 2020 and 2021.

Coming out of this temporary program Town administration felt that it should continue to encourage eligible businesses to develop or extend a patio so as to further assist such businesses recovery from the effects of the pandemic. However, Administration recommends that a permanent by Law with clear and consistent guidelines should be developed for that purpose as opposed to the temporary measures that were put in place during the pandemic.

As a result, Council has before it the proposed Sidewalk Patio By-Law (By-law number2160).

This By-Law will provide going forward a clear and consistent application process for applications and approvals. In particular the highlights of the proposed by-law are as follows:

- "Eligible Business" means a commercial operation that serves food and beverages;
- "Sidewalk Patio" means a clearly delineated area upon a municipally owned sidewalk, designed for a group of tables and chairs and other accessories for the use and consumption of food and beverages sold to the public from, or in, an Eligible Business;

A temporary Patio on Town Lands shall be permitted seasonally for the period of April
1st to October 1st;

The requirements for approvals of Sidewalk Patios will require the Approval Manager to
circulate Sidewalk Patio applications to the appropriate Town Departments and/or
agencies to determine whether the sidewalk patio design and location is acceptable. As
a result of such circulation the Approval Manager may refuse to grant approval or
impose such terms and conditions as are consistent with the guidelines contained
herein.

Although the temporary provisions have been revoked, it is recommended to continue Sidewalk Patios and further support local businesses in the Town of Essex.

Eligible Business Owners looking to operate a Sidewalk Patio on municipally-owner sidewalks will be able to continue by applying through the Sidewalk Patio By-Law 2160.
