7.1 Monthly Reports

Police Service Board Report for Essex and Monthly Overview for January 2023

Inspector Ferguson stated that the top calls for service in January were the following:

Property Checks (76) Officers are attending houses as requested by residents who are away on vacation, businesses in the evening to ensure they are locked and cottages to ensure they are not broken into.

Motor Vehicle Collisions (28) there were no fatalities, the number of collisions is aligned with January 2022, this is believed due to weather.

Traffic Enforcement (24) Councillor Verbeek, Vice Chair questioned why the calls for service were so low. She stated that traffic enforcement should be more of a priority over property checks.

Inspector Ferguson stated that they are trying to get the traffic enforcement numbers up higher in the coming months. She continued that residents do call to have their properties inspected when on vacation which drives up the hours used on property checks.

Mayor Bondy stated that residents are requesting to see the Ontario Provincial Police on the roadways and stated that traffic enforcement should be top priority.

Impaired (1) Mayor Bondy stated that there are empty beer cans on the side of County and Concession roads throughout the Town of Essex. She continued that the Harrow news did a write up on the concerns of this activity and she stated that the Town does not condone drinking and driving. She continued that she would like to see the Ontario Provincial Police back this initiative up with their presence and any statements they give regarding this subject. She stated that an Office provided a statement to the Harrow news and they stated that the debris was due to blue boxes being blown around. She continued that this was

unacceptable and that the Town and Police need to work together to combat drinking and driving.

Auxiliary Hours (4) Inspector Ferguson stated that she has met with the new Auxiliaries and she is hopeful that Essex will see an increase in the hours as spring and summer are also approaching.

7.2 Windsor Essex County Crime Stoppers Report

Inspector Ferguson advised the members that there was a Chuck A Puck February 18 2023 at the WFCU Centre and that there is another one transpiring Wednesday, March 15 2023.

7.3 Strategic Plan

Doug Sweet, CAO, Staff Liaison, stated that this item will be an on-going item on the agenda and asked the board when would they be available to discuss top priorities. He also asked Inspector Ferguson how she would prefer the boards priorities be relayed to her.

Inspector Ferguson stated that the priorities can be given to her in the form of a letter.

Mayor Bondy, Chair, stated that Council should discuss what their top priorities are for the strategic plan as they hear from the community regarding policing concerns. She continued that those objectives can be brought back to the board to review and a report can then be provided to the Ontario Provincial Police.
