Location of Property: Vacant Land on 5th Concession Road (Colchester South, Ward3)

Purpose of Application: A consent application has been received by the Town of Essex Committee of Adjustment for the lands identified as vacant land on 5th Concession Road, in the former Township of Colchester South (Ward 3). The applicant is proposing to sever a \pm 1 acre (0.40 ha) parcel from the existing \pm 90.06 acre (36.44 ha) agricultural lot. The retained agricultural lot is proposed to have an area of \pm 89.06 acres (36.04 ha). The applicant is proposing this consent as a lot addition to 6287 6th Concession Road.

Note: An application for Minor Variance has also been received for the subject lands (File Number: A-13-23). The public notice for the minor variance application has been included with this notice.
