Purpose of Application: A consent application has been received by the Town of Essex Committee of Adjustment for the vacant lands on the East side of County Road 13, in the former Township of Colchester South (Ward 3). The applicant is proposing to establish a maintenance easement over an existing sanitary sewer line which will benefit the lands located at 108 County Road 50 East. The easement will be 7.43 metres x 296.9 metres (24.4 ft x 974.1 ft) in size for a total area of 0.21 ha (0.54 acres).

If a person or public body that files an appeal of a decision of the Committee of Adjustment for the Town of Essex in respect of the proposed consent does not make written submissions to the Committee before it gives or refuses to give a provisional consent, the Ontario Land Tribunal (OLT) may dismiss the appeal.
