### Recommendation(s)

**That** Economic Development-2020-13 entitled COVID-19 Business Grant Funding Update prepared by Nelson Silveira, Economic Development Officer dated September 8, 2020 be received.

**That** Council approve extending the deadline of the Business Relaunch Grant until October 2, 2020 for all businesses assessed in the commercial class.

## Purpose

To provide Council with an update on the Digital Growth Grant and Business Relaunch Grant programs that were launched to assist businesses during the COVID-19 emergency.

### **Background and Discussion**

### **Digital Growth Grant**

In June of this year, Council committed \$15,000.00 to support the Digital Growth Grant

program for businesses in the Town of Essex. The Essex Centre BIA contributed \$5,000.00 to this initiative and the Small Business Centre provided in-kind support to administer the program and review funding applications. Funds for this program were intended to directly support local businesses efforts to make the shift to become more digital.

In total, the \$20,000.00 available under the Digital Growth Grant program has been fully allocated with \$1,000.00 grants distributed to the following twenty (20) businesses:

#### **Business Relaunch Grant**

In July of this year, Council committed \$100,000.00 to support the Business Relaunch Grant program that has provided up to \$500.00 in funding to businesses throughout the municipality to assist in restart costs during the COVID-19 emergency. To-date the program, which has been embraced by our local businesses, has distrusted \$43,827.15 in grant funding, garnering uptake from 92 businesses.

Originally, the deadline for the Business Relaunch Grant applications was August 31, 2020. However, Administration is recommending that the deadline be extended until October 2, 2020 as some businesses begin to reopen as a result of the August 12, 2020 announcement that our region would be entering Stage 3 of the provincial government's reopening plan. This would allow all remaining businesses in the Town of Essex that are assessed under the commercial class to access this funding.

### **Financial Impact**

The \$15,000.00 committed to the Digital Growth Grant program has been fully allocated with no remaining balance in the fund.

Council approved allocating \$100,000.00 to support the Business Relaunch Grant program. A total of \$43,827.15 has been distributed with \$56,172.85 remaining in the fund. Sufficient funds therefore remain to support the extension of this program until October 2, 2020.
