### Recommendation(s)

**That** Economic Development-2020-12 entitled Community Improvement 2020 Plan Budget Update prepared by Nelson Silveira, Economic Development Officer dated September 8, 2020 be received, and

**That** Council approve the transfer of \$66,107.46 from the Harrow and Colchester CIP Reserves to the current budget year.

### **Purpose**

To provide Council with information regarding the transfer of funds from reserves to the 2020 Harrow and Colchester CIP budget.

### **Background and Discussion**

The Town of Essex Community Improvement Plans (CIP) were created to stimulate private sector investment through municipal incentive-based programs. The CIP has a variety of grant

programs for eligible property owners that invest in façade improvements, new signage, and building renovations and improvements. These programs have facilitated and encouraged community change by providing grant funding for new development in three separate project areas that include Essex Centre, Harrow, and Colchester/County Road 50.

In 2020, the CIP program, particularly in Harrow and Colchester, has seen a particularly high level of interest and applications. Applicants requesting funding are often submitting applications under multiple programs and for projects that are much larger in scope than previous years. As a result, the initial \$100,000 budget for both Harrow and Colchester is nearly fully allocated for 2020.

#### Transfer from CIP Reserves

To continue funding projects that are having a positive impact on the aesthetic appearance of properties in our project areas, Administration is recommending that Council approve transferring \$66,107.46 from the Harrow and Colchester CIP Reserves to the current CIP budget. Rather than transfer funds from the Essex Centre CIP to the Harrow CIP budget, this approach will allow Administration to continue approving projects in all project areas without having an adverse effect on applicants applying under the Essex Centre CIP.

## **Financial Impact**

The \$66,107.46 transfer from Harrow and Colchester CIP reserve to the 2020 budget for those project areas would leave no remaining balance in the reserves for the Harrow and Colchester CIP. However, \$29,182.40 remains in the Essex Centre CIP reserves. A transfer from Essex Centre CIP reserves is not required at this time.
