6.1 Treasurer's Report -2023 Budget Review

6.2 Report from Council Representative

Councillor Katie McGuire-Blais provided the following report.

Highlights from the 2023 approved budget are as follows;

The Wilson Parking lot (behind Dollarama) has been approved for repair;

- The Streetscape has been rescoped and has now gone out for Tender. The rescope is from Arthur Ave to Cameron Ave., including both intersections, and is expected it to start May 2023 and end November 2023;
- Essex Region Conservation Authority ("ERCA") has obtained the old railway track lands.
 This runs though the downtown core. Over the next few years, ERCA will be fundraising to install bike/walking paths. This will be a great addition to the Heritage Park. This also might be a capital project for the BIA to work on to help fund the Heritage portion of the path;
- Phase 2 of the electrical project for Heritage Park will be discussed in the 2024 budget. This is a capital project that the BIA might want to invest in;
- The Essex Sip N' Shop Committee has had their first meeting with a second scheduled on March 1, 2023 6:00 pm in the Barnette Room. Tickets this year will be \$30, which includes a \$10 donation to our charity partner, a wine tumbler with the Sip N' Shop logo, 3 samples of wine, 1 full glass of wine along with an individual snack; and
- The Sip N' Shop committee has requested the BIA to sponsor this event providing for a total sponsorship of \$5000 which would include a second tent and added BIA vendors.

Krista Sweet from FATE shared that she currently participates in the BIA business branded commercials, the Downtown Dollar program and all seasonal promotional opportunities. She mentioned that while the Downtown Dollar program is successful, she inquired whether there was a way to better spread the dollars out to allow for more customers to purchase them. Ms. Sweet provided suggestions such as reviewing the times of sale, spreading out the campaigns etc. She noted that her business could benefit from a possible marketing/social media training. She also noted that FATE currently relies heavily on social media for their marketing and promotions and could benefit from a form of radio advertisement.




