Recommendation(s)

That Community Services-2023-04 entitled Special Event Notice – Essex Fun Fest – July 6 to 9, 2023 prepared by Jake Morassut, Director, Community Services, dated April 3, 2023, be received, and

That Council approve a temporary noise exemption under Noise By-Law #2038 from 3:00 PM to 1:00 AM on Thursday July 6, 2023, from 11:00 AM to 1:00 AM on Friday July 7, 2023, from 11:00 AM to 1:00 AM on Saturday July 8, 2023, and from 11:00 AM until 6:00 PM on Sunday July 9, 2023, at the Essex Centre Sports Complex to accommodate the entertainment for the Essex Fun Fest; and

That Council approve closing Fairview Avenue West between 360 Fairview Avenue West (Essex Civic Centre) and Hanlan Street, and Hanlan Street from Fairview Avenue West to Victoria Street in Essex Centre between 10:00 AM and 11:00 AM for the Essex Fun Fest Parade with the lineup prior to the event taking place at the Essex Civic Centre; and

That Council approve the Essex Fun Fest for Significant Event Status for the purposes of applying for their Special Occasion Permit (SOP) for their event on July 6 to 9, 2023.

Purpose

To obtain Council approval of a noise exemption under Noise By-Law #2038, and for approval of a Significant Event Status for the purpose of applying for a Special Occasion Permit for the Essex Fun Fest on July 6 through July 9, 2023. As well, to receive Council approval for a road closure on Fairview Avenue West between 360 Fairview Avenue West and Hanlan, and Fairview Avenue West from Hanlan Street to Victoria Street in Essex Centre during the Essex Fun Fest Parade on July 8, 2023 from 10:00am to approximately 11:00am.

Background and Discussion

The Alcohol and Gaming Commission of Ontario (AGCO) requires a municipality to designate a special event as 'Significant Event Status' for the purpose of those applying for liquor licensing permits and approval, regarding their operation of liquor services during their event. For the AGCO to issue the permits allowing the sale of liquor during events on municipal property, they require the municipal designation. The AGCO regulations also state that this designation must be secured annually for the organization to obtain a Special Occasion Permit.

Town Administration and the Special Events Resource Team (SERT) have reviewed the event and have no objection to any of the activities and recommend recommend an exeption to Noise By-Law #2038 at the Essex Centre Sports Complex to accommodate the entertainment for the Essex Fun Fest at the below dates and times:

3:00 PM to 1:00 AM on Thursday July 6, 2023

11:00 AM to 1:00 AM on Friday July 7, 2023

11:00 AM to 1:00 AM on Saturday July 8, 2023

11:00AM until 6:00PM on Sunday July 9, 2023

The Special Event Resource Team also concurred with closing Fairview Avenue West between 360 Fairview Avenue West (Essex Civic Centre) and Hanlan Street, and Hanlan Street from Fairview Avenue West to Victoria Street between 10:00 AM and 11:00 AM for the Essex Fun Fest Parade with the lineup prior to the event taking place at the Essex Civic Centre.
