It has been brought to my attention that my letter that was emailed to council Oct. 6/20 may be placed on the agenda for discussion. If so, I wish to convey all of my concerns regarding the draconian measures placed by governments during this covid pandemic.

In regards to PCR tests, there are multiple videos and news articles that convey these tests are not suitable nor are they licensed for diagnostic purposes. Kary Mullins, the creator of the PCR test, now being used with its false positives to diagnose Corona virus exposure says about the PCR test "you can find anything in anybody, it's a misuse to claim that it's meaningful".

German Lawyer Dr. Fullmich (has started a class action law suit) says "there can be no legal doubt that any person or company who suffer loss of income is entitled to full recovery of such damage caused by responsible officials, governments, and manufacturers of PCR tests, this is because the decisions are almost entirely made on those tests which contrary to official assurances are completely unsuitable to detecting a virus".

There is ample evidence PCR tests are faulty at best. Even the Ontario medical officer said that "at least 50% of tests are false positive" so the numbers mean NOTHING. Christine Elliott Deputy Premier of Ontario has stated "there are numbers being added from spring/summer", so "climbing number" as they call it are due to this as well as increased testing. The fact that our council does not know these things is embarrassing. Mr. Mayor, for you to dismiss this topic in council the other night, due to 700 cases proves your ignorance.

People's lives and livelihoods are at stake and their health. I am not talking about Covid, I am talking about the use of masks. There are multiple peer reviewed articles showing the harm masks can cause. I have seen reports of headaches, dizziness, nausea, impetigo, pleurisy, pneumonia, strep throat and death from carbon dioxide poisoning due to these masks. As well, a transcript from Dr. Margarite Griesz-Brisson's recent extremely pressing video message. Dr. Margarite Griesz-Brisson MD, PhD is a Consultant Neurologist and Neurophysiologist with a PhD in pharmacology with special interest in neurotoxicology, environmental medicine, neuroregeneration and neuroplasticity. What she says about masks and their effect on our brains: "The rebreathing of our exhaled air will without a doubt create oxygen deficiency and a flooding of carbon dioxide. We know that the human brain is very sensitive to oxygen deprivation. There are nerve cells for example in the hippocampus, that can't be longer than 3 minutes without oxygen - they cannot survive. The acute warning symptoms are headaches, drowsiness, dizziness, issues in concentration, slowing down of the reaction time - reactions of the cognitive system."

However, when you have chronic oxygen deprivation, all of those symptoms disappear, because you get used to it. But your efficiency will remain impaired and the undersupply of oxygen in your brain continues to progress.

We know that neurodegenerative diseases take years to decades to develop. If today you forget your phone number, the breakdown in your brain would have already started 20 or 30 years ago.

While you're thinking, that you have gotten used to wearing your mask and rebreathing your own exhaled air, the degenerative process in your brain are getting amplified as your oxygen deprivation continues.

The second problem is that the nerve cells in your brain are unable to divide themselves normally. So in case out governments will generously allow as to get rid of the masks and go back to breathing oxygen freely again in a few months, the lost nerve cells will no longer be regenerated. What is gone is gone.

There is no unfounded medical exemption from face masks because oxygen deprivation is dangerous for every single brain. It must be the free decision of every human being whether they want to wear a mask that is absolutely ineffective to protect themselves from a virus.

For children and adolescents, masks are an absolute no-no. Children and adolescents have an extremely active and adaptive immune system and they need a constant interaction with the microbiome of the Earth. Their brain is also incredibly active, as it has so much to learn. The child's brain, or the youth's brain is thirsting for oxygen. The more metabolically active the organ is, the more oxygen it requires. In children and adolescents every organ is metabolically active.

To deprive a child's or an adolescent's brain from oxygen, or to restrict it in any way, is not only dangerous to their health, it is absolutely criminal. Oxygen deficiency inhibits the development of the brain, and the damage that has taken place as a result CANNOT be reversed.

The child needs the brain to learn, and the brain needs oxygen to function. We don't need a clinical study for that. This is simple, indisputable physiology. Conscious and purposely induced oxygen deficiency is and absolutely deliberate health hazard, and an absolute medical contraindication.

An absolute medical contraindication in medicine means that this drug, this therapy, this method or measure should not be used - is not allowed to be used. To coerce an entire population to use an absolute medical contraindication by force, there must be definite and serious reasons for this, and the reasons must be presented to competent interdisciplinary and independent bodies to be verified and authorised.

When in ten years, dementia is going to increase expodentially, and the younger generations couldn't reach their god-given potential, it won't help to say "we didn't need the masks".

Who is responsible for this crime? The ones who want to enforce it? Theo ones who let it happen and play along, or the ones who don't prevent it?

This lockdown and the stipulations that go with it is an egregious over reach of the government, for a virus that has a 99.8% chance of survival? The state of emergency should be canceled, what is happening in our hospitals today does not warrant a state of emergency.

I suggest council look up Randy Hillier MPP, he has some very informative videos as well and is the only member of government that I see that has the integrity to push back on these covid methods and lockdown.

So not only are these measures nowhere close to be scientifically justified – they're also completely against our God given Charter of Rights and Freedoms, that were granted by God and not from man. For the government to take away these rights, they must demonstrate they meet the Oakes Proportionality Test – a test in which they would struggle to pass step 1.
