David McBeth, Manager, Capital Works and Asset Management explained that the Hot Asphalt Program aims to repair roads that only require asphalt to help prevent further deterioration. He noted that Wright Road was chosen as it is a major outlet for Colchester area and due to the large traffic volumes, it warrants replacing the road now to avoid a more extended shutdown and extensive cost.

David McBeth, Manager, Capital Works and Asset Management presented Council with a proposed Sidewalk Patio Policy for downtown businesses within the Town of Essex to ensure sidewalk patios on Municipal sidewalks have proper traffic control and protection, accessibility for pedestrians, and a consistent aesthetic to match the new streetscape designs.
