# 7.3 Concession Lease - CAP-23-11-005

Revise Page 5, Last two paragraphs have been revised.

During the agreement's term, the tenant possesses food rights to sell and use the leased concession stand premises. If fundraising events opt for a food truck or catering service, a \$200 fee per food truck will be charged to event; if the Concession stand is not required the tenant is entitled to a 25% share, while 75% goes to the Co-An Park. Co-An hosted events are exempt from this arrangement. Additionally, Co-An Park will oversee all food rights for family reunions, Jack n Jills, weddings and leased land at the Essex Steam and Gas Engine Museum.

**8.1 Music Jamboree** is requesting fees be waived for food rights: \$200 catering fee plus \$1.50 per Rib Dinner, also requesting donation for the use of cooler \$75 fee
