Charmaine Valbuena, Social Planning Coordinator and Stephen Lynn, Social Policy and Planning Human & Health Services, City of Windsor, and Chris Loreto, Managing Partner and Nabiha Chowdhury, Senior Consultant, StrategyCorp. Inc. provided a presentation regarding Pathway to Potential (P2P) Renewed Strategy and seeking approval for the Pathway to Potential Strategy.

Chris Loreto and Nabiha Chowdhury joined the meeting virtually from a remote location.

Stephen Lynn and Charmaine Valbuena attended the delegation in person.

Chris Loreto explained that the refreshed P2P plan includes an updated vision, mission, values, and three goals that will guide Pathway to Potential's work over the next four years: Strengthening Priority Neighbourhoods, Advancing Affordable Regional Programs, and Measuring Regional Impact. Under the three goals, there are 10 initiatives, 29 action items, and 26 deliverables.

Following the approval of the new Strategy, the P2P team will begin preparing for the circulation and implementation of the Strategy and launch an RFP process for community agencies to deliver the Neighbourhood Programs.

Chief Lammers provided Council with data regarding sudden cardiac arrest and the opportunity for the public to support the Public Access Defibrillator (PAD) mapping project.

Chief Lammers encouraged all businesses to register their devices using the PulsePoint database. PulsePoint logs information regarding the location, hours of availability and the persons responsible for maintenance of the devices. The PulsePoint database is available to call operators at the Ambulance Communication Centres. Access to this information during an emergency could help save a life with early intervention.

Katherine Hebert explained that with the recent retirement of the former Director, Legislative and Community Services/Clerk, while recruitment is still underway, the County is in a position where there is only one designated individual who is authorized to carry out the legislated duties of the Clerk. In consideration of this, and to ensure that the County of Essex has adequate redundancy to avoid any potential risk to the municipality a second appointed individual is a prudent measure.

Prior to having a designated Deputy Clerk in 2020, past Chief Administrative Officers had been appointed for this purpose. That is the recommendation at the present time, to appoint the County's current CAO, Sandra Zwiers as a second Deputy Clerk for those circumstances that may arise where there is an absence or inability to perform the statutory duties of the Clerk under the Act, by the existing Deputy Clerk.
