Background and Discussion

As per O. REG. 588/17 ASSET MANAGEMENT PLANNING FOR MUNICIPAL INFRASTRUCTURE section 4. "Every municipality shall prepare its first strategic asset management policy by July 1, 2019 and shall review and, if necessary, update it at least every five years."

The policy has been reviewed to ensure that relevance is maintained. Updates to the original policy have been made to include verbiage indicating that asset management is an organizational wide effort. Responsibilities have been established including an executive lead and an asset management working group.
