Subject: Arena Canteen Lease Agreement

Recommendation(s)

That Community Services Report 2024-31 entitled Arena Canteen Lease Agreement prepared by Jake Morassut, Director, Community Services dated August 12, 2024, be received;

That the Council approve entering into a lease agreement with M&M Concessions for leased space at 243 McAffee Street in Harrow and 60 Fairview Avenue West in Essex Centre for a three-year term, commencing September 1, 2024, subject to the general terms and conditions as outlined in By-Law 2363; and

That By-Law 2363 be read a first, a second and a third time and finally passed on August 12, 2024.

Purpose

To have Council approve entering into a lease agreement with M&M Concessions at both arena facilities, located at 243 McAffee Street in Harrow and 60 Fariview Avenue West in Essex Centre, for food service and concession operations.

Background and Discussion

The Town of Essex Community Services Department previously oversaw the operations of the Harrow Arena canteen up to 2011. Since 2012, the Town issued Request for Proposals for third party to operate Town of Essex canteens.

Specific to the Harrow Arena, there have been three different operators since 2012. The Town issued a Request for Proposal for the 2023-24 season in August 2023 for service and operations of the Harrow Canteen. The Town of Essex had no proponents provide submissions during the tendering process. After the tendering process was closed, the proponent submitted to adminstration that he would be willing to operate the Harrow Arena Canteen for the upcoming 2023-24 season and a proposal was submitted for consideration. M&M Concessions, represented by Tim Stanley, met all requirements of the scope to operate the canteen, and the contract was awarded accordingly.

The Essex Centre Sports Complex opened in September 2008 and the Essex Kinsmen Club operated the canteen at the facility until the club disbanded prior to the 2012-2013 season. M&M Canteen was the successful proponent for a Request for Proposal issued in 2012 and they have been operating the Essex Centre Sports Complex canteen since 2012. M&M Canteens have been an excellent partner and they have worked extremely well with the user groups. The M&M Canteen's operating agreement was a five year term, expiring in August 2024.

As the operator is now entered into two different agreements, both of which are up for renewal, Administration recommends the the agreement encompasses both concession operations into one agreement, which will assist in continuity of services at both locations.

While lease agreements, whereby the Town is the lessor, are not specifically identified in the **Town's current procurement by**-law 2129, the Town follows the same general guidelines used for general acquisition. In Section 27.02, the policy allows for the ability for administration to make a recommendation for a defined term, in the absence of an existing contract renewal

option, if in the Town's best interest to do so. Given the dollar threshold and lack of interest in recent tenders, it is believed a formal bid process would not likely produce significant pricing differences. There is also the potential risk in posting a tender that due to timing and proximity to the ice season, the canteens aren't operational for sometime.

The existing propinent, M&M Canteen Services has been an excellent partner for the Town in operating the Essex Centre Complex and the Harrow Arena canteen; Administration is recommending extending the lease for an additional four years with the option to extend an additional four years.

Administration has discussed the agreement with the proponent and M&M Concessions will increase their existing rate by the current CPI of 2.7%, which equates to a monthly rate of \$20.54 (plus HST) for the Harrow Canteen, and \$475.41 (plus HST) for the Essex Canteen, totalling \$495.95 (plus HST).

Financial Impact

The current operating agreement has the proponent paying annual revenues of \$3,703.28 (plus HST) at the Essex Centre Sports Complex (September to April) and \$140.00 (plus HST) at the Harrow Arena (November to March). The new proposed 2024-2025 rate, adjusted for Consumer Price Index increases (CPI) of 2.7% will be \$3,803.28 (plus HST) at the Essex Centre Sports Complex, and \$143.78 (plus HST) at the Harrow Arena, totalling \$3,947.06 (plus HST). These lease rates will continue to provide alternative sources of revenues for their respective cost centres. The rate will be adjusted annually on September 1st, by CPI, prior to the start of their operating season.
