## 5. Reports from Administration

## 5.1 Capital Works and Asset Management-2024-18

RE: 5-Year Capital Proposed Plan

Kevin Girard, Director, Infrastructure Services, provided an overview of the 5-Year Capital Plan and explained that two items have been completed which includes the 10-year roads forecast and the 5-year capital forecast for future water, wastewater and storm water projects. He explained the core infrastructure assets and replacement costs stating that 80% of assets are in fair or better condition.

Director Girard explained that the purpose of capital forecasting is to renew critical infrastructure, implement growth to support development, ensure cost, schedule projects and for financial planning and fiscal responsibility.

David McBeth, Manager, Capital Works and Infrastructure, provided an overview of the 5-Year Capital Plan for reconstruction projects, roads, bridges, sidewalks and trails, watermains and storm sewers. He noted that Administration is recommending an approval of the projects in principle to be able to schedule the required inspection, reports and engineering design required to have these projects ready for their scheduled year.

Council directed questions to Administration regarding priority roads and plans for specific roads.

Council requested that the adoption of the 5-Year Capital Plan be postponed to a future Council Meeting to allow for additional time for Council to review the documents, meet with Administration and receive public feedback.
