At is Regular Meeting of Council on July 4<sup>th</sup>, 2022, Council Resolved the following:


#### R-22-07-336

# Background and Discussion

The public-right-of way, also known as municipal road allowance, refers to Town-owned land. Typically, the public right-of-way includes the roadways, sidewalks and sections of boulevard land used for town owned and public utility services, as shown in **Figure 1**.

The utilities found in the public-right-of-way can include the following: Water, Wastewater and Storm sewers, Electrical, Gas and Telecommunications infrastructure.

These utilities are buried at various depths and locations within the right-of-way. Public utility companies have legislative rights to install and maintain their infrastructure within The **Town's right**-of-way.

Utility work within the Right-of-way is coordinated with Town of Essex staff through a "Utility Construction Municipal Consent (MC) Permit". This assures the utility location, and new installations do not conflict with existing Town owned infrastructure. In addition to the required permits, utility companies and their contractors working in the Town owned right-of-way carry the necessary level of insurance coverage and are subject to all other applicable Federal, Provincial and municipal laws/by-laws.

#### Privately Owned Infrastructure in The Right-Of-Way

Privately owned infrastructure typically only benefits a private homeowner or a privately owned company.

The Town owned Right-of-way should be solely reserved for Town owned infrastructure and Public Utilities that directly serve and benefit our residents as a whole.

The Town of Essex does understand that there are applications where private property owners could benefit from having privately owned infrastructure installed within the Town owned Right-of-Way, typically in a road crossing perpendicularly. Privately owned infrastructure shall not be installed parallel to the Right-of-Way, in these cases private property owners would need to utilize adjacent private lands through a private property easement.

Any private property owner that wishes to have private infrastructure cross a town owned right-of-way would be subject to Legal agreement that clearly identifies the roles and responsibilities of the private owner.

This does not guarantee a private property owner the right to access the Town owned Rightof-Way for private infrastructure. Each inquiry will be reviewed and approved/denied on a case-by-case basis.
