### Recommendation(s)

**That** Fire and Rescue Services Report – 2025-03 entitled “Grant Funding – The Ministry of the Solicitor General, Office of the Fire Marshal - Fire Protection Grant”, prepared by Jason Pillon, Fire Chief dated March 3, 2025, be received, and

**That** Council approve the 2025 post budget approval for the Capital Project “Firefighter Cancer Prevention Supplies” in the amount of \$24,691.35, to be fully funded from grant funding received from the “The Ministry of the Solicitor General, Office of the Fire Marshal” which will further strengthen and improve the Essex Fire and Rescue Services cancer prevention measures.

### Purpose

Council approval is required to approve allocations outside of the annual budget.

## **Background and Discussion**

In 2024, the Ministry of the Solicitor General, Office of the Fire Marshal, received Treasury Board (TB) approval for a \$30 Million grant over three years to support municipal fire services in acquiring essential equipment and addressing other needs, including health and safety measures, minor infrastructure improvements, and specialized tools. The goal is to enhance and improve the level of fire protection services provided. These funds are allocated through the Fire Protection Grant.

The first year of the Fire Protection Grant focuses on firefighter health and safety, particularly cancer prevention measures, as well as minor infrastructure updates. These priorities were identified based on input from fire service stakeholders across Ontario regarding the risks and challenges faced by firefighters in their roles.

The Ministry has defined four eligibility categories:

- Cancer Prevention – Equipment (e.g., exhaust extraction systems for fire stations, gear washing machines to remove contaminants, etc.)
- Cancer Prevention – Personal Protective Equipment (e.g., face pieces, balaclavas, etc.)
- Cancer Prevention – Minor Infrastructure (e.g., installation of showers in fire stations, etc.)
- Technology – Minor Infrastructure (e.g., providing internet access to fire stations that currently lack connectivity to enhance training and communication, etc.)

The Essex Fire and Rescue Service is enhancing firefighter safety and cancer prevention with upgraded personal protective equipment (PPE), decontamination practices, hood exchanges, and clean cab concepts. However, a challenge remains in cleaning all exposed gear promptly without affecting firefighter availability. While spare bunker gear is available, there are insufficient second sets of structural gloves, balaclavas, and helmet liners, creating a risk of skin contamination. Although these items can be washed, quick drying is often not possible during back-to-back emergencies.

The Town of Essex has been approved for \$24,691.35 in funding. This funding will be dedicated to acquiring advanced personal protective equipment (PPE) specifically designed to reduce the risk of cancer among firefighters. The upgrades will include enhanced PPE, with the aim of equipping each firefighter with an additional balaclava (protective hood), an extra pair of firefighting gloves, and spare helmet liners for the stations. This second set of gloves, balaclavas, and helmet liners will ensure that firefighters always have access to clean PPE during emergency responses, bolstering the department's cancer prevention initiatives.

### **Financial Impact**

There is no net financial impact on the Town of Essex as the project is fully funded through a \$24,691.35 grant from the Ministry of the Solicitor General, Office of the Fire Marshal.
