### Recommendation(s)

That Operations-2025-01 entitled, "Erie Wellington Crosswalk" prepared by Norm Nussio, Manager of Operations and Drainage, dated March 3, 2025, be received.

### Purpose

As per the regular council meeting on October 21, 2024, Council directed Administration to prepare a report on the feasibility of installing a crosswalk at the intersections of Erie Street South and Wellington Street in Harrow.

## Background and Discussion

**That** Council direct Administration to review the feasibility and cost of adding a controlled pedestrian crossing over County Road 13 (Erie St South) at Wellington Street in Harrow.

**Seconded By** Councillor Matyi


In February 2016, the Town undertook a review of all pedestrian crossings in urban centres and presented it to Council. At that time, all uncontrolled pedestrian crossings on collector and arterial roads were addressed using various measures. It was also supported by Council to continue the practice of establishing controlled crossings on collector and arterial roads to improve vehicular and pedestrian safety in the Town.

In order to install a crosswalk at Erie and Wellington (Figure 1 below) we would be required to install a level 2 type D crossing as per the Ontario Traffic Manual OTM Book 15 (figure 2 below).

The cost of installing this crosswalk would consist of 3 new concrete approaches with tactile plates to meet AODA loading zone/ramp requirements also would need to install proper signage and pavement marking for the crossing as per OTM Book 15 requirements. Estimated cost to implement this crossing is approximately \$17,500.00 based on recent cost comparison from the South Crossing Report that was presented to council in September 2024.

## Financial Impact

If council wishes to proceed, this project can be included in the proposed 2026 capital budget for deliberation.
