# The Corporation of the Town of Essex

## **By-Law Number 2426**

Being a by-law to name the extension of the street "Ducharme Lane" on the Draft Plan of Subdivision for Part of Lots 1 and 2, Concession 12, and the section of the road from the 12th Concession to Ducharme Lane in the Geographic Township of Colchester in the Town of Essex.

**WHEREAS** the Council of the Corporation of the Town of Essex deems it appropriate to name certain highways within the Town of Essex;

**AND WHEREAS** Section 11 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended provides that municipalities may pass by-laws respecting highways;

**AND WHEREAS** Section 270 (1) of the Municipal Act, 2001, S.O. 2001, c. 25, as amended requires that the Corporation of the Town of Essex adopt and maintain policies with respect to the circumstances in which the municipality shall provide notice to the public and, if notice to be provided, the form, manner and times notice shall be given;

**AND WHEREAS** the Council of the Town of Essex did pass By-Law Number 989, being a by-law to prescribe the form and manner and times for the provision of notice on the 7th day of December, 2009;

**AND WHEREAS** on February 7, 2025, written notice was posted on the Town's website advising that the Corporation of the Town of Essex intends to name a certain highway.

**NOW THEREFORE** be it resolved that the Council of The Corporation of the Town of Essex hereby enacts as follows:

- 1. **That** the extension of the street "Ducharme Lane" on the Draft Plan of Subdivision for Part of Lots 1 and 2, Concession 12, Geographic Township of Colchester in the Town of Essex and the section of the road from the 12th Concession to Ducharme Lane in the Geographic Township of Colchester in the Town of Essex. on Schedule "A" hereto.
- 2. **That** Schedule "B" attached hereto is the written notice that was posted on the Town of Essex website on February 7, 2025; and.
- 3. **That** this By-Law shall come into full force and effect upon the registration in the Land Registry Office for the Registry Division of Essex (12).


# Town of Essex Notice of Street Naming
