Councillor McGuire-Blais provided the following report:

- Council received a notice of motion to create a poster and slogan about harassment and bullying.
- The Balance Wellness Centre was contacted regarding diversity training.
- It was suggested that the BIA could offer HR and diversity training for small business employees, possibly discussed at the upcoming BIA Mix & Mingle.
- Downtown garbage remains an issue. Council requested a report on bin quantity and placement, with an update expected in June and a full report by the end of summer.
- Patio season is approaching, and a new patio policy is in effect. Businesses interested in a patio should contact the Economic Development Department for more information.
- Some bollards from the streetscape project are being removed due to parking concerns. Planters or other barriers will be installed in their place.

- Some business owners and staff continue to park in front of their stores. A reminder may be needed to encourage keeping those spaces available for customers.

Summary from Downtown Walkthrough – April 3, 2025

Participants: Kelly and Raeann (Economic Development Department)

As part of the April 3rd downtown walkthrough, Kelly and Raeann met with several business members. Below is a summary of the key concerns, suggestions, and feedback received:

Accessibility:

Multiple businesses expressed the need for accessible entrances but noted that the cost of upgrades is a barrier.

• Grants & Funding:

There is strong interest in financial support for equipment upgrades, energy efficiency improvements, staffing, and point-of-sale (POS) systems.

• Web & Technology Needs:

Several businesses requested assistance with modernizing their websites and enhancing online sales capabilities.

Operational Challenges:

Common issues include staffing shortages, limited space, rising rents, and decreased foot traffic.

• Municipal Concerns:

Business owners raised concerns about the Town's procurement processes and challenges with commercial recycling pickup.

• Positive Feedback:

Some members expressed appreciation for local community programs and noted the value of recent grant information, particularly for new or transitioning businesses.
