Recommendation(s)

The following three (3) recommendations are provided for Council's consideration:

- 1. That Legal and Legislative Services-2021-18 entitled "Appointment of Animal Control Appeal Committee" prepared by Shelley Brown, Deputy Clerk, and dated August 23, 2021 be received; and
- 2. **That** Council appoint Terri Coutts, Richard Kokovai, and Chris Ortner as members of the Animal Control Appeal Committee for the limited purpose of adjudicating an upcoming appeal(s) (to be scheduled); and further
- 3. **That** an honorarium of \$100 be paid to each member of the Animal Control Appeal Committee for serving an adjudicative role for a specific purpose.

Purpose

The purpose of this report is to appoint three members to the Animal Control Appeal Committee for the limited purpose of adjudicating an upcoming appeal (to be scheduled).

Background and Discussion

At the July 5, 2021 Regular Council Meeting, Council considered a Legal and Legislative Services Report regarding an upcoming appeal hearing to be convened pursuant to Section 4.07.3 of the Animal Care and Control By-Law.

By resolution R21-07-286, Council adopted the report and concurred with the following recommendation:

That Council grant an exemption from the requirements of Section 4.01 of the Animal Control By-Law as it relates to the composition of the Appeal Committee, and direct that the members of the Appeal Committee for the upcoming appeal hearing(s) (to be scheduled) shall be comprised of three members of the general public to be appointed who have declared that they will serve impartially and that they do not have a conflict of interest in the matter to be adjudicated.

In an effort to attract suitable candidates, advertisements were placed in local newspapers during the month of July. As a result, the following individuals have been identified as suitable candidates and have accepted the responsibility of adjudicating the matter(s) in an impartial manner:

- Chris Ortner former Branch Manager, Orkin Canada

The date the appeal(s) to be heard has yet to be scheduled, but will be shared with the parties involved and announced on the online public calendar once the details are confirmed.

Financial Impact

As the members of the Animal Control Appeal Committee are serving an adjudicative role for a specific purpose, it is recommended that an honorarium of \$100 be paid to each member. This honorarium will cover both preparation time and the date of the appeal hearing itself.
