6. Unfinished Business

6.1 Traffic Enforcement Officer

Chair Councillor Kim Verbeek provides the members with a summary of what transpired between October 2020 to current day with the discussions and inquires into the Town of Essex obtaining a Traffic Enforcement Officer.

She advised that administration, the Police Service Board and OPP have tried multiple ways to combat speeding through out the Town of Essex. She stated that some of the ways were via social media, newspaper articles, increased RIDE programs, speed trailer along with targeting enforcement at identified areas of concern, with other public outreach and education. She stated that unfortunately none seemed to curve or combat the speeding issues and concerns and stated that there needs to be an enhancement to the Essex OPP contract to provide for a Traffic Enforcement Officer. Sergeant Peter Marshall OPP Contract Analyst, stated that the Town is currently seeking one (1) officer to be contracted for the purposes of Traffic Enforcement. He advised that this officer would be simply utilized for the purposes of Traffic Enforcement. He advised that the hours would not be 24/7 as it would be one officer on contract and work times cannot accommodate for 24/7 patrol. He advised that the enhancement should assist in bringing down speeding throughout the Town of Essex. He advised that the cost of the contact position for the first year would be roughly \$197,048.00 and stated that the second year the cost would go down to roughly

\$176,119.00. He advised that there is a percentage increase yearly so the numbers provided may not be accurate but would not increase drastically.

Peter Marshall also stated that in 2022 the new Policing Act will not hold contracts with any Municipality however stated that the enhancements will be upheld should the Town wish to move forward.
