#### 10.8 Legal and Legislative Services-2021-14

RE: Fireworks By-Law Review and Updates

 Current By-law 124 being a By-law regulating the sale and the setting off of fireworks in the Town of Essex.

Robert W. Auger, Town Clerk/Solicitor, Legal and Legislative Services, provided a verbal report on the proposed Fireworks By-Law stating that it was a collaborative effort from By-Law Enforcement, the Building Department, Fire

Services and Legal and Legislative Services. He noted that the current Fireworks By-Law (By-Law 124), is out of date, does not address certain health and safety concerns and Is not practical in its application for both the residents and from an enforcement point of view. The new proposed By-Law 2011 expands the holidays when fireworks can be sold, extends the periods of time that licensed retailers can sell fireworks, prohibits the possession of fireworks to people under the age of 18, prohibits firecrackers and flying lanterns,

The proposed By-Law further expands the list of holidays that Family Fireworks can be set off (adding Independence Day, Civic Holiday, and Labour Day) and adds a period of time before and/or after each holiday that Family Fireworks can be set off without a permit.

The proposed By-Law makes a distinction between three (3) types of fireworks (family fireworks and the larger type Display and Pyrotechnic fireworks) each with their own definitions, restrictions and regulations. It was noted in the proposed By-Law that Family Fireworks is a low hazard, recreational firework while Display Fireworks and Pyrotechnic fireworks are high hazard. No person shall set off display fireworks in the Town unless they have been granted a permit and the event falls on the designated dates list in the By-Law.

Mr. Auger noted that permits are not required for family fireworks if set off on the prescribed dates but noted that the new by-law formalizes a detailed application/permit process for the larger Display and Pyrotechnic type fireworks. Mr. Auger also noted that there is currently no fee for Display and Pyrotechic Permit applications and that administration is asking Council to support the possibility of a fee for such applications which would consistent with other municipalities.

Councillor Vander Doelen expressed concerns with a By-law that prohibits firecrackers. Rick Arnel, Fire Chief, stated that family fireworks would not require a permit to set off fireworks. The only fireworks that would require a permit are display fireworks or pyrotechnics which are large events that require various regulations. He also noted that under the Explosive Act of Canada firecrackers are illegal.

Councillor Garon noted that he was not in favour of the permit fee as it would be difficult to enforce the fee. He also recommended that we should consider providing neighbours notice.

Mr. Auger explained that the Fire Department would have the discretion in the by-law to make it a requirement to provide notice when obtaining a permit for the larger type firework displays.

Deputy Mayor Meloche asked if fireworks could be set off on a day other than those listed.

Mr. Auger replied that yes it was possible but it would need to be authorized through a permit for the larger type fireworks or if otherwise approved in writing from the Fire Department.
