5. Public Presentations/Correspondence

5.1 Request for Additional Funding of \$1,000.00 for 2021 Season from Co-An Park Committee (See attached letter)

Ms. Bissonnette explained that due to the COVID-19 restrictions, some events at the park were cancelled and as a result they were not able to generate sufficient revenue to cover their 2021 expenses. At it's November 10, 2021 meeting, the Committee passed a motion to request additional funding in the amount of \$1,000 from the Town of Essex and the Town of Amherstburg to cover the expenses for 2021.

5.3 Request for Relief from Non-Resident Cemetery Rates- Milan and Eileen Meleg (see attached correspondence)

Michael Meleg addressed the Committee on behalf of his parents, Milan and Eileen Meleg. Mr. Meleg stated that his parents lived in the Harrow area for over 60 years. Mr. Meleg further stated that due to health reasons his parents moved into their son's home in Windsor. As a result of the move, his parents were not eligible for the resident rate for the purchase of the interment rights pertaining to the two lots recently purchased at Colchester Memorial Cemetery. They are requesting that as former long-term residents of the Town they be granted the resident rate and be given a refund of the difference in fees.

Re: Verbal Report regarding interest charged on drain bill

Ms. Giurissevich explained that interest was applied as a result of a payment being made to the wrong account by the resident. She advised that in this instance the resident applied the payment to the tax account rather the general receivable account as stated on the invoice. Ms. Giurissevich further explained that drain bills and property taxes should be paid on two separate accounts. Ms. Giurissevich added that payment instructions are indicated on drain bills and when a payment is not applied to the correct account, an administration fee of \$27.14 to correct the error charged.
