Recommendation(s)

The following three (3) recommendations are provided for Council's consideration:

- a) That report Community Services-2022-002 entitled "Colchester Harbour Operating Agreement Renewal with the Department of Fisheries and Oceans Canada" be **received**;
- b) That Council **approve** By-Law Number 2121 to renew the operating agreement of the Colchester Harbour with the Department of Fisheries and Oceans under the same terms and conditions for an additional five (5) years commencing February 1, 2022; and
- c) That Bylaw 2121 be read a first, a second and a third time and finally passed on February 7, 2022.

Purpose

To obtain Council approval to renew the lease with the Department of Fisheries and Oceans to operate the Colchester Harbour beginning February 1, 2022.

Background and Discussion

The current operating agreement of the Colchester Harbour with the Department of Fisheries and Oceans is set to expire on January 31, 2022, and the Town has received the renewal agreement for an additional five (5) years under the same terms and conditions of past agreements.

The Town has been in partnership with the Department of Fisheries and Oceans to operate the Colchester Harbour ever since the Municipality was incorporated and even prior when it was under the operation of Colchester South Township.

Financial Impact

As per the agreement the rent is Five Hundred Dollars (\$500.00) plus taxes per annum or twenty percent (20%) of Gross Revenue plus taxes whichever is the higher amount. The past fees paid as per the agreement were \$28,086 in 2018, \$27,194 in 2019, and \$21,307 in 2020. This has been the standard rent requirement in all previous agreements.
