## Recommendation(s)

**That** Capital Works and Infrastructure-2022-02 entitled "2021 Engineering Services for Bridge Replacement/Rehabilitation" prepared by Kevin Girard, Director, Infrastructure Services dated February 7, 2022 be received, and

**That** Council award the Engineering Services for Bridge Rehabilitation (RFP-ID-21-024) to RC Spencer Associates Inc. in the amount of \$61,152.67 including all non-refundable Harmonized Sales Tax.

**That** Council approve the additional funding of \$11,152.67 above the approved 2022 Capital Budget of \$50,000 for Engineering for Various Bridges and Culverts (PW-21-0011) from the Town's Asset Management Lifecycle Reserve.

#### **Purpose**

In accordance with the Town Procurement By-Law Number 1043, a Request for Proposal (RFP) was issued for Engineering Services for the 2021 bridge rehabilitation projects. Since the cost estimate included in the successful proponent's proposal exceeds the approved 2022 Capital Budget, Council's authorization is required to approve additional funding.

## **Background and Discussion**

The RFP for Engineering Services was issued in October of 2021 and closed on November 17, 2021, requesting that qualified engineers provide proposals for engineering design and construction administrative services for three structures within the Town of Essex:

- Concrete Rigid Frame Structure # 200303 McLean Road/4<sup>th</sup> Concession Road
- Concrete Rigid Frame Structure # 103901 South Malden Road / County Road 11
- Soil Steel Culvert Replacement # 204004 Ferris Road / 4th Concession

The Request for Proposal received was evaluated using a scorecard approach, taking into consideration the fee proposal, qualifications and experience, understanding of project scope, quality of the proposal, work schedule, methodology, value added and innovation concepts.

The proposal review process included a team made up of:

- Kevin Girard, Director, Infrastructure Services
- Norm Nussio, Manager, Operations and Drainage
- Jackson Tang, Assistant Manager, Business Services

After reviewing each proposal as submitted and totaling the scores, R C Spencer Associates Inc. scored the highest. R C Spencer Associates Inc. addressed all areas of the scope as identified in the request for proposal.

## **Financial Impact**

The 2022 Capital Budget had an approved amount of \$50,000 (Carry forward Project PW-21-0011) for Engineering for various bridges and culverts. The successful proponent's total cost for these services is \$61,152.67 including non-refundable HST. Therefore, the 2022 approved budgeted amount for PW-21-0011 is not sufficient to cover the overall total cost of the project. Additional funds in the amount of \$11,152.67 are required to be transferred from the Town's Asset Management Lifecycle Reserve to cover this shortage.
