6.1 Gerard Rood, Professional Engineer

Re: Report from Rood Engineering Incorporated dated August 26, 2021 regarding Bassett Drain: Bridge for MN 2430 County Road 20, Geographic Township of Colchester South, Project 2021D012, Town of Essex, County of Essex.

Mr. Rood presented the overview of the report. Mr. Rood explained that new access bridge is being provided to serve as the access to the severance from an existing residential parcel. Mr. Rood added that all of costs for the new bridge construction and incidentals be assessed against the residential lands of Fernando and Maria Pedro and Jenny Cacilhas. Mr. Rood noted that 50% of the future maintenance costs for the bridge shall be assessed as a Benefit against the abutting property (severance from roll# 730-01600) and remaining balance of 50% be assessed pro-rata against the upstream lands and roads based on their Outlet Liability assessment in the 2007 Gerard Rood report Maintenance Schedule of assessment. Mr. Rood asked if Jenny Cacilhas has any questions.

Ms. Cacilhas replied that she has no questions or concerns.
