9.1 Essex-Windsor Solid Waste Authority - 2022 Budget

Michelle Bishop, General Manager and Steffan Brisebois, Manager of Finance and Administration, EWSWA to present the 2022 EWSWA budget. (Refer to Item 12.1 under Reports and Questions).

Michelle Bishop explained the increase of 4.1 percent in the proposed budget and outlined the impacts to the respective County municipalities. Ms. Bishop explained the estimated impacts were based on collection rates for disposal from 2021 and consider growth in the region. She confirmed that the 2022 budget had been approved by both the Board prior to this meeting.

Each of the recommendations were reviewed providing details to revenue and expenditures variances. Ms. Bishop explained the Authority experienced a surplus due to increase in the value of recycled materials.

Discussions included forecasts of current and future service models and the potential impacts to the Authority budget.

The total assessment to County of Essex municipalities and to the City of Windsor is to also include the increase in municipal tonnage from 2021 to 2022 being an additional 4,950 tonnes representing \$198,000. The overall 2022 assessment to Windsor and the County municipalities will be \$13,810,740.

Katherine Hebert updated the status of the initiatives outlined in the Five Year Accessibly Plan for 2018-2022. Ms. Hebert explained that the Plan was a requirement of the Accessibility for Ontarians with Disabilities Act (AODA) and the County would be developing the next five-year plan for 2023-2027 throughout 2022.

Ms. Hebert explained that despite the challenges of 2021, the County of Essex maintained their focus on accessible initiatives. She noted an audit by the Accessibility Directorate was conducted in 2021 and the County was found to be compliant with all seven areas of review.

The Essex County Accessibility Advisory Committee continued to meet monthly throughout 2021 and collaborated with Essex Region Conservation Authority to offer feedback regarding the condition of local trail systems under their care. It was reported that the WE Check the Trails initiative would continue throughout 2022.

Chief Krauter explained the purchase of the ambulances was in accordance with the County's Asset Management Plan. Chief Krauter explained that production delays were anticipated and it was the desire of the service to place the order as soon as possible to mitigate delays.

Chief Krauter explained the units were budgeted for in the 2022 Budget, however unanticipated increases across the supply chain would require a transfer from reserve to fully furnish the cost of the purchase. The purchase price would be reevaluated in the 2022 Asset Management Plan for future acquisitions.
