4. Land Acknowledgement Statement

5. Recording of Attendance

Warden McNamara attended the meeting virtually from the Essex County Civic Centre, Council Chambers. All other members of Council participated in the meeting virtually, via video conferencing from alternate remote locations.

6. County Warden's Welcome and Remarks

Warden McNamara welcomed the members of County Council, Administration and members of the public and delivered the following greeting:

"Two years living in the shadow of a global pandemic is a long time. In our third spring since COVID-19 swept the world, we finally feel like we are stepping out into the sun.

The number of deaths and hospitalizations are declining. Restrictions are being lifted in Ontario and elsewhere. We are making plans to go places we haven't been able to go and see people we haven't been able to see for the last two years.

Businesses that had to close their doors intermittently, invest in safety measures and restrict their services for two years are moving ahead. We cannot thank local businesses enough for all they have overcome to keep operating and serving the community during this pandemic. They deserve our ongoing patronage and support for so many reasons.

We are grateful to Essex County and Windsor health-care and other frontline workers for all you have endured to get us through the darkest hours of COVID-19. We again want to thank the staff at Essex-Windsor EMS, Sun Parlor Home and other county departments for continuing to serve residents despite the obstacles and hardships you have faced.

Residents of Essex County, thank you for following health protocols for two years, getting vaccinated and being there for your neighbours. It has not been easy battling this virus. It has been stressful. And, at times, it has been frustrating. Thank you for your patience.

Springtime is a hopeful time. We want you to feel hope. If you are still struggling, that is understandable. That is OK. We all need to move forward in our own way and at our own pace.

We need to keep looking out for each other. We need to respect each other's choices about whether to continue wearing masks in public and social distancing. We need always to be kind.

We are ready to be done with COVID-19, but it is not done with us. We are transitioning to life with this virus. It will continue to be a presence and a threat, but one we can handle if we take the lessons we have learned these past two years to heart. We need to act before the virus hits us again.

We need to think like Wayne Gretzky. We need to skate to where the puck is going.

How can we do this? By getting vaccinated and ensuring we have all three shots. At this stage, we know getting three doses is an excellent way to avoid severe illness and death from COVID-19. Some may need four doses to get the best protection. We are all likely to need additional vaccinations in the future.

Vaccination is a simple measure that is getting us out of the cycle of pandemic waves of hospitalizations and deaths. If you are still hesitating, this is the time to see a health-care provider and get that protection.

Let's step out in the spring sunshine and move forward knowing we have done everything possible to brighten the future.

Chief Administrative Officer Mike Galloway has asked for a few minutes to speak about the dedication and diligence of Essex County employees over the course of this pandemic.

I would also like to commend Mike for his steady leadership in these trying times."

County CAO Mike Galloway offered greetings thanking Essex County departments and staff for their steadfast commitment to service during the pandemic and highlighted some accomplishments throughout.

9.1 Windsor-Essex Ontario Health Team (WEOHT)

WEOHT Co-chairs Bruce Krauter, Claudia den Boer and Kristen Kennedy, to provide County Council with information on the recently approved Windsor-Essex Ontario Health Team.

Claudia den Boer explained that her term as co-chair has come to an end and Kristin Kennedy would be taking her place as co-chair with Chief Bruce Krauter, Essex-Windsor EMS.

Ms. Den Boer explained the three-year journey to gain approval by the Honourable Minister Christine Elliott as an Ontario Health Team (OHT). She described how pandemic requirements had accelerated progress and provided unique opportunities to innovate the healthcare system.

During the pandemic, Windsor-Essex County was identified as a high priority community. The information provided by the Province organized high priority communities by postal code. This data allowed the new mobile health team, called the COVID Response and Stabilization Team (CRST), specific areas to focus their efforts and offer real time support.

Ms. den Boer explained how the mobile component of the CRST team dovetails with the OHT as community need continues. The OHT goal is to improve overall access to care and would utilize a mobile clinic to provide wellness checks and primary care in underserviced neighbourhoods.

Chief Krauter outlined the value of the contributing organizations in the OHT and explained how collaboration is key to the success of the program. Claudia identified that the OHT will endeavor to find efficiencies and define the needs of the communities but it would be the responsibility of the Ministry of Health to fund.

12.7 Regional Food and Organics Waste Management Program

Report number 2022-0316-CCS-R04-MB, Regional Food and Organics Waste Management Program, dated March 16, 2022, from Mary Birch, Director, Council and Community Services/Clerk and Sandra Zwiers, Director, Financial Services/Treasurer

Mary Birch provided the report outlining the process of review and consultations with the seven local tier municipalities of the County of Essex pertaining to participation in the Food and Organics Waste Management Program.

Sandra Zwiers provided information regarding the financial implications of this project. Highlighting that the regional approach provides opportunities to realize economies of scale. Ms. Zwiers pointed out that a more fulsome participation in the program would realize savings for all.

Representatives from Kingsville and Essex spoke in opposition to County Council making a decision to advise EWSWA that all County municipalities would participate in a regional Food and Organics Waste Management initiative, stating that their municipalities did not wish to participate at this time. Discussion included the risks of incomplete local tier participation in the project and the legal implications if County Council proceeded with a regional model, without authorization from Kingsville and Essex.
