#### Recommendation(s)

That Legal and Legislative Services-2022-24 entitled Amendments to Procedural By-Law and Electronic Participation in Meetings be received

**That** By-law 2159 Being a by-law to provide Rules of Procedure for the Conduct of Meetings of the Municipal Council and its Committees and Boards be read a first, a second, a third time and be finally passed this 16<sup>th</sup> date of May 2022., and

**That** By-law 1926 be repealed accordingly.

## **Purpose**

To reflect updated proposed amendments to the Procedural By-law relating to the holding of Council Meetings and electronic participation as a result of the Town's termination on May 2, 2022 of the Declaration of Emergency made in March 2020 in response to the COVID-19 pandemic.

Council approval via by law is required in order to make any amendments to its procedural bylaw pertaining to the meetings of Council and its committees

### **Background and Discussion**

At its May 2, 2022 Regular Meeting Council received Legal and Legislative Services-2022-16 (attached hereto as Schedule "A") entitled Procedural By-Law and Electronic Participation in Meetings in which Council was asked if it endorsed the status quo provisions of the procedural by-law relating to electronic participation in meetings or if it wished to provide additional direction(s) relating to proposed amendments to the procedural by-law in reference to electronic participation in meetings post declaration of emergency. After deliberation and discussion at that May 2, 2022 meeting Council directed the Clerk to return to Council with proposed amendments to the current Procedural by-law reflective of that Council discussion and deliberation that took place at the May 2 meeting.

As a result attached hereto as Schedule "B" are proposed amendments (in red-line) to the current procedural By-law (By-law 1926) to reflect the Council discussion and deliberations that took place at the May 2 Council meeting together with a couple of minor incidental amendments. It is recommended (assuming Council is agreeable to the proposed changes) that instead of a further amending by-law to By-law 1926 it might be more efficient to have the current Procedural By-law 1926 simply repealed and replaced with a new consolidated by-law that incorporates these latest changes. As a result attached hereto as Schedule "C" for Council's consideration is By-law 2159 Being a by-law to provide Rules of Procedure for the Conduct of Meetings of the Municipal Council and its Committees and Boards.
