Introduction

Every effort is taken to ensure that election services respond to and meet the needs of the community. This commitment includes ensuring that procedures are in place to respond to complaints respecting services and information provided in the course of Oshawa's municipal election.

Purpose

The purpose of this procedure is to define how complaints respecting election services may be submitted to City Clerk Services. Certain matters have specific legislated procedures for complaints and appeals that are beyond the jurisdiction of the City Clerk and this procedure. Municipal Elections Act, 1996, S.O. 1996, c. 32 (hereafter: "the Act").

Application

This procedure establishes processes which apply only to complaints associated with municipal election services within the jurisdiction of the City Clerk. It does not apply to matters for which a process has been established by legislation or regulation.

Implementation

City Clerk Services has established a process to acknowledge and review complaints related to election services and supporting processes within five (5) business days. In extraordinary circumstances (e.g. on Voting Day, during advance voting opportunities or during a work stoppage), City Clerk Services may not be in a position to guarantee that the established standard can be achieved.

Candidate Meetings and Other Events Held During the Campaign	The City Clerk performs an administrative function related to the conduct of the municipal election within the framework established by the Act. Candidate-related events organized by other institutions or organizations during the municipal campaign period, such as all-candidates debates or fundraising events do not fall within the mandate, authority or responsibility of the City Clerk.
Conduct of a Candidate or Member of Council	The City Clerk performs an administrative function related to the conduct of the municipal election within the framework established by the Municipal Elections Act. The Act does not provide the City Clerk with investigative or enforcement powers.
	An individual with concerns about the conduct of an individual candidate may contact Durham Regional Police if the matter relates to an offence under the Criminal Code of Canada.
	The City's Integrity Commissioner plays a role in ensuring the appropriate conduct of sitting Members of Council. Additional information, including information on how to file a complaint under Council's Code of Conduct is available at: https://www.oshawa.ca/city-hall/city-council-governance.asp

Election Results Recount	The City Clerk performs an administrative function related to the conduct of the municipal election within the framework established by the Municipal Elections Act. Oshawa City Council has adopted a Municipal Election Recount Policy that may apply in limited circumstances; however the City Clerk does not possess the authority to independently direct a recount beyond the circumstances provided for by the Municipal Elections Act.
	Where the Municipal Election Recount Policy is not engaged, an eligible elector may request Oshawa City Council to consider a recount, or to the Superior Court of Justice. A decision of Oshawa City Council and the Superior Court of Justice may be appealed to the Divisional Court.
Controverted Election	An application may be made to the Superior Court of Justice to challenge the validity of an election. A decision of the Superior Court of Justice may be appealed to the Divisional Court.
Election Signs	Responsibility for the enforcement of the election sign standards established by the City of Oshawa and Durham Region rests with the City's Municipal Law Enforcement section. Late Filing of Financial Statements	All candidates and registered third party advertisers must file a financial statement (and auditor's report in certain circumstances) with the City Clerk before 2:00 p.m. on the last Friday in March in the year following the election, or by the legislated deadline where a supplementary and/or subsequent financial statement is required.
	The City Clerk does not have authority to grant an extension or set aside the requirement to file a financial statement. Additionally, the City Clerk and cannot waive any mandatory penalties that may apply due to the failure of a candidate or registered third party to file a financial statement prior to the deadlines established by the Municipal Elections Act.
	If a candidate or third party advertiser misses the deadline, they may file within a 30-day grace period, provided a \$500.00 late filing fee is paid.

Page 5	The candidate or registered third party may also, before the last
	day for filing, apply to the Superior Court of Justice for an order extending the time for filing the financial statement. A judge may grant an extension for the minimum period of time necessary for the candidate or third party advertiser to file the statement, but may not issue an order granting an extension of more than 90 days.
