## Recommendation(s)

**That** Operations-2022-05 entitled Results of Tender-Supply of Backhoe Loader 2022 prepared by Norm Nussio, Manager of Operations and Drainage dated June 6, 2022, be received, and

**That** Council award Request for Tender- Supply of Backhoe Loader 2022 to Brandt Tractor Ltd. in the amount of \$192,326.40 including non-refundable harmonized sales tax.

## **Purpose**

In accordance with the Town Procurement By-Law Number 2129, Council approval is required for purchases in excess of \$120,000.00.

#### **Background and Discussion**

In accordance with the Town's 2022 Capital Budget project number PW-22-0001 for the replacement of unit #512 (Cat Backhoe) a Request for Tender, following the guidelines as set out in the Town's Procurement By-Law Number 2129 was posted both on the Town's website and Merx, and closed on April 13, 2022 at 3:00:00 pm.

The Tenders were reviewed for arithmetic errors, completeness, legibility, revisions, and irregularities. In addition, there were no apparent unbalanced prices in the Schedule of Items and Prices. The results of the submitted tender prices are noted in Table below:

Name of Tenderer	Total Price including non-refundable Harmonized Sales Tax (1.76%)
Kucera Group Tecumseh	\$188,459.52
Brandt Tractor Ltd.	\$192,326.40

Having confirmed with the lowest tenderer (Kucera Group Tecumseh), they are not able to meet all the required specifications as specified in the Tender document. It is recommended that this contract be awarded to the compliant bid (Brandt Tractor Ltd).

## **Financial Impact**

The 2022 Capital budget included \$220,000 for project number PW-22-0001 for the replacement of Unit #512 (Cat Backhoe). Therefore, the purchase of the Backhoe Loader in the amount of \$192,326.40 is within the budgeted funds for this project.

There will be some additional items that need to be purchased such as custom lighting and corporate lettering/logos that will be procured using By-Law 2129. The remaining unspent funds of \$27,673.60 from PW-22-0001 will be sufficient budget for the cost of the custom lighting and lettering.
