### Recommendation(s)

**That** Legal and Legislative Services Report 2022-27 entitled Request to Name Alley between McAffee and Victoria, Ward 4 prepared by Shelley Brown, Deputy Clerk dated June 6, 2022, be received;


**That** Council authorize the naming of the alley between McAffee and Victoria in Harrow as Morency Alley in accordance with the Town's street naming by-law (By-Law 601); and

**That** public notice be given on the Town's website in accordance with the Town of Essex Public Notice Policy No. 017.

### Purpose

In accordance with By-Law 601, requests to name or change the name of a roadway in the Town of Essex are to be chosen on a lottery basis, or other such method as determined by Council are to be brought forward to Council for approval.

A request for a street name has been submitted by Robert Duncan, property owner of the lands described as Alley King W S/S Rear, as identified below.



The Chief Building Official advised that municipal addresses are only issued on public roadways and in the absence of a recognized street name, a municipal address could not be issued. The alley was assessed by the Town's Building, Planning and Operations Divisions and it was

determined that it meets the definition of a roadway as described in the zoning by-law and provided by the Planning division as follows:

"Alley" means a highway, having a maximum width of less than 7 meters (23 feet), providing a means of access to a lot.

"Highway" means all allowances for roads made by the Crown surveyors or established under the authority of any statute, all roads on which public money has been expended for opening them or on which statute labour has been usually performed, all roads dedicated by the owner of the lands to public use and all alterations and deviations of and all bridges over such allowances. A private road, used by and jointly maintained by the owners of lots that abut or cross the road, such road having been in use at the time of the incorporation of the Town of Essex, shall be deemed to be a highway for the purpose of recognizing the existing lots accessed by it and for the application of the applicable zoning by-law provisions to such lots.

Therefore, it was recommended that the alleyway be named in accordance with By-Law 601, the Town's street naming by-law.

By-Law 601, being a by-law to establish the procedure for the naming of the highways within the Town of Essex, includes schedules of names for highways which recognize deceased members of the Royal Canadian Legion Branches 201 and 338. These schedules are the primary sources of names to be chosen on a lottery basis or such other method as determined by Council.

The lottery took place on Tuesday, May 24, 2022, through the use of an online random number generator. As a result, the name chosen was Morency Alley.

## **Financial Impact**

The cost to construct and erect the road sign is expected to be minimal and will be covered under the Operations operating budget.
