Recommendation(s)

That Legal and Legislative Services-2022-22 entitled 2022 Municipal Accessibility Plan prepared by Robert Auger, Town Solicitor/Clerk dated May 16, 2022 be received.

Purpose

To advise Council on plans to ensure that persons with disabilities have the opportunity to participate fully in the 2022 Municipal Election process.

Background and Discussion

Pursuant to Section 12.1(2) of the Municipal Elections Act, 1996 (S.O. 1996, Chapter 32, Schedule), "the Clerk shall prepare a plan regarding the identification, removal and prevention of barriers that affect electors and candidates with disabilities and shall make the plan available to the public before voting day in a regular election."

The attached 2022 Municipal Election Accessibility Plan is intended to identify measures that the Town of Essex will implement to ensure that persons with disabilities have the opportunity

to participate fully in the election process during Advance Voting and on Election Day, October 24, 2022.

Among other things, the plan addresses how the Clerk's Department will train election staff on providing accessible customer service to candidates and electors. It also outlines accessible communication methods and provides details on how to offer feedback that will assist the Clerk's Department in delivering an accessible election.

A copy of this plan will be included in each candidate's nomination package and will be available at Town Hall in print and on the Town's Municipal Election webpage. A copy of this Plan has also been sent to the Town of Essex Accessibility Advisory Committee for review and ongoing feedback and comments as the election period progresses.

Financial Impact

There are no financial impacts to establishing a municipal election accessibility plan.
