Being a by-law to Amend By-Law No. 2215 being a by-law to Establish and Appoint Town of Essex Boards and Committees for the 2022-2026 Term of Council

WHEREAS the Council of The Corporation of the Town of Essex did on December 19, 2022 pass By-Law No. 2215 being a by-law to Establish and Appoint Town of Essex Boards and Committees for the 2022-2026 Term of Council;

AND WHEREAS on December 4, 2023, the Council of The Corporation of the Town of Essex adopted By-Law 2237 being a by-law to establish and delegate certain powers to the Town of Essex Appeals Committee;

AND WHEREAS on December 4, 2023, the Council of The Corporation of the Town of Essex resolved to dissolve the current Property Standards Committee upon the publishing of a Notice of Hearing of the Appeals Committee;

AND WHEREAS the Council of The Corporation of the Town of Essex accordingly now deems it expedient and necessary to dissolve the Property Standards Committee and all persons appointed thereto;

NOW THEREFORE be it resolved that the Council of The Corporation of the Town of Essex hereby enacts as follows:

 That the wording in Section 4 of By-Law No. 2215 being a by-law to Establish and Appoint Town of Essex Boards and Committees for the 2022-2026 Term of Council be deleted and expunged and replaced with the following wording to remove the Property Standards Committee being:

"That the following represents the recognized Advisory and Ad-Hoc Committees of Council and such other Committees and Boards not established by Council but for which Town of Essex appointed representatives serve and provide service on behalf of the Town of Essex on such Boards/Committees for the term of council from November 15, 2022 to November 14, 2026, and that the appointed members of all such Committees shall sit at the pleasure of Council during such term of Council.

- 2. **That** Schedule A of By-Law No. 2215 being a by-law to Establish and Appoint Town of Essex Boards and Committees for the 2022-2026 Term of Council be amended to revoke the appointment of the following Property Standards Committee members effective upon the publishing of a Notice of Hearing of the Appeals Committee:
 - a. Dorene Lester;
 - b. Matthew Child; and
 - c. Phillip Pocock.
- 3. By the provisions listed above, the Property Standards Committee is effectively dissolved.

That this By-Law shall come into full force and effect upon the publishing of a Notice of Hearing of the Appeals Committee.
