

The Corporation of the Town of Essex

By-Law Number 2322

Being a by-law to designate Community Safety Zones within The Corporation of the Town of Essex

WHEREAS Section 214.1 of the Highway Traffic Act, R.S.O. 1990 and amendments thereto provides that the Council of a Municipality may by By-Law designate a part of a highway **under its jurisdiction as a community safety zone, if, in the Council’s opinion, public safety is of special concern on that part of the highway;**

AND WHEREAS Section 214.1 (5) of the Highway Traffic Act, RSO 1990, c H.8 states that no by-law or regulation made under this section becomes effective until signs are erected, in accordance with this Act and the regulations, on the designated part of the highway;

AND WHEREAS the Council of the Town of Essex is of the opinion that public safety is of special concern on highways adjacent to schools and public parks.

NOW THEREFORE be it resolved that the Council of The Corporation of the Town of Essex hereby enacts as follows:

1. **That locations in the Municipality designated in Schedule “A” Ward 1, Schedule “B” Ward 2, Schedule “C” Ward 3, and Schedule “D” Ward 4 are hereby designated as Community Safety Zones;**
2. **That** By-Laws 466, 767 and 915 being by-laws to designate community safety zones in The Corporation of the Town of Essex are hereby repealed upon the final passing of this by-law; and
3. **That** this By-Law shall come into full force and effect upon the final passing thereof and the erection of the signs prescribed in accordance with the Highway Traffic Act.

Read a first, a second and a third time and finally passed on April 15, 2024.
