### Purpose

The purpose of this report is to provide a progress update to Council on the status of initiatives and action items identified in the Council-adopted Climate Change Adaptation Plan.

### Background and Discussion

**At the Regular Meeting on February 16, 2021, Council adopted “Climate Ready: A Climate Change Adaptation Plan (CCAP) for the Town of Essex, 2021-2026”. The CCAP provides a** roadmap for both Council and Administration on how we can prepare and adapt to the future impacts of climate change through policy, process, infrastructure, and communication

developments. The presented action items in the CCAP were developed in a way to avert damages to public and private assets, operations, services, heritage, economy, and the quality of life of residents. As identified in the CCAP, Administration will be delivering an Annual Report to Council which will highlight the actions that have been initiated and implemented across the Corporation and the community.
